School Districts Under Investigation for Role in Weaponization Against Parents

The House Committee on the Judiciary and the Select Subcommittee on the Weaponization of the Federal Government, led by **Representative Jim Jordan (OH)**, addressed “the Biden Administration’s use of federal law-enforcement and counterterrorism resources against parents voicing concerns” about their school children in a March 21, 2023 Interim Staff Report.

On June 27 of 2023, journalist and parental rights activist **Kelly John Walker** wrote members of Congress including Jordan, to share specific information on the targeting of school parents and was subsequently invited to the nation’s capital.

“Representative Jordan delegated a staff team to coordinate with me,” reports Walker, “and since July of 2023, I’ve been providing representatives with updates on the weaponization against school parents by the National School Board Association (NSBA), AG Merrick Garland’s DOJ, and the Biden Administration in coordination with specific school districts.”

In March of 2024, Walker brought a coalition of parental advocates to meet with legislative teams in Washington, D.C. After the meeting, **Congressman Andy Ogles (TN)** issued a statement:

It has come to light, through diligent investigation by Chairman Jim Jordan and the House Judiciary Committee, that the Biden Administration has used the instruments of federal power and combating terrorism as a sword against our citizens who dare to voice concerns...It’s unconscionable. Whistleblowers have revealed that the FBI has gone so far as to tag these parents as potential threats. Let me be clear: being a concerned parent is not a crime, and speaking up for your child’s future is not an act of terrorism. The 2024 election is the best chance the American people have had in a long time to elect representatives that will reign in federal bureaucracy and prevent the far Left from continuing to target people of faith, conscience, and conservative principles.”

“Unfortunately, the FBI is a corrupt institution,” **Congressman Paul Gosar (AZ)** added. “The FBI has turned into a domestic surveillance agency that attacks and monitors honest citizens and harasses people based on their politics. This cannot be allowed any longer.”

Since the 2024 election, Walker has been in communication with members of the Trump administration, including incoming Cabinet members. “More than one member of the administration contacted me, offering

to personally brief President Trump,” according to Walker. “Legislators have reached out to the Trump administration, requesting an Executive Order to restore these victims of political weaponization.”

“Immediate action should be taken to provide assistance and restitution to those families harmed by this weaponization,” wrote Walker in a briefing [found on the FreedomTalk Website](#), which lists the following remedial actions:

- Formal written apology from the federal government
- Compensation for legal defense fees, lost wages, economic damages incurred by victims
- Full pardon and record expungement (including by state, county, and city governments that co-conspired with the federal government)
- Pressure on the Media and Search Engines to retract defamatory content

“Meticulous research traces the origin of this weaponization to the Vail, Arizona School District, under the supervision of [Superintendent John Carruth](#), beginning in September of 2021. The demonization of concerned parents was a deliberate attempt to politicize the issue and distract attention away from youth suicide and mental health crisis linked to lockdown policies. School districts continued to enforce disastrous policies to avoid jeopardizing millions of dollars in CDC funding.”

Walker wrote in his June 27 email, “Parents have a Natural Right to inquire into the education, care, health and wellbeing of their children and expect answers. Case law has established that parents have exclusive rights over their children that supersede those of the State. This was firmly established by *Pierce v. Society of Sisters* (1925), in which the U.S. Supreme Court held that ‘the fundamental theory of liberty upon which all governments in this Union repose excludes any general power of the State...*The child is not the mere creature of the State*; those who nurture him and direct his destiny have the right, coupled with the high duty, to recognize and prepare him for additional obligations.”

“So many American families were traumatized and had their reputations and finances ruined after being deemed ‘enemies of the State,’” said Walker. “The federal government has a duty to quickly restore these people to the Life, Liberty and Happiness they enjoyed prior to this government-sponsored terrorism.”
