LETTER FROM THE EDITOR

Since 2021, American parents have paid a heavy price for defending their children.

Americans across the nation were targeted by their own government, including parents who have spoken out at school board meetings—questioning harmful COVID policies, Critical Race Theory indoctrination, and radical gender theory—policies that threaten their children’s wellbeing. They’ve endured FBI surveillance, public smear campaigns, job loss, financial ruin, and even wrongful arrest—and this persecution *continues!*

Sam Sorbo and I founded the Parents Demanding Justice Alliance (PDJA) to undo this injustice. PDJA stands on the sacred ground of family, fighting to right the wrongs inflicted on parents who dared to speak the truth.

The Dossier Heard Around Washington

On July 15, we organized a historic press conference on Capitol Hill, sponsored by Rep. Andy Ogles, bringing together members of Congress, journalists, and families silenced for too long. Parents from across the country shared their stories, exposing the raw reality of DOJ retaliation and school district abuse.

We formally hand-delivered the detailed Targeted Parents Dossier—a compilation of targeted parent testimonies and evidence—directly to Trump advisor **Vince Haley** and Weaponization Working Group Director **Ed Martin**. It documents patterns of abuse, federal coordination with local authorities to intimidate dissenters, and a roadmap for accountability.



The stories of political persecution will infuriate you.

A Blueprint for Justice: The EO

I drafted an Executive Order for the President—designed not only to end the DOJ’s weaponization against parents, but to provide restitution and full public vindication. It calls for a Parental Rights Protection Task Force, formal DOJ investigations, exoneration of targeted parents, and financial relief for those harmed. We put it directly into the hands of those who can deliver it.

The Smoking Gun: AFL’s Confirmation

Shortly after our press conference, America First Legal released internal DOJ documents proving Garland’s October 4, 2021 memo was politically motivated and coordinated with the Biden White House. DOJ attorneys warned it had no legal basis—warnings ignored as counterterrorism tools were deployed against everyday parents. For PDJA, this was vindication: **the DOJ was weaponized, parents’ rights were trampled, and those responsible must be held accountable.**

Is Justice Only for the Well-Connected?

On August 14, during a press briefing about Adam Schiff's alleged leak of classified information, White House Press Secretary Karoline Leavitt quoted Kash Patel, pledging, "With our partners at DOJ and Congress, we'll have the chance to uncover how political power may have been weaponized and to restore accountability."

Such pledges—from Patel, Pam Bondi, and others—sound promising. But will that justice reach ordinary Americans, or remain the privilege of the well-connected? The weaponization of government under the Biden administration is no longer in question—the evidence is overwhelming. Yet the imbalance is glaring: high-profile figures get swift defense, while middle-class patriots—targeted for exercising their rights—are left to endure the life-shattering fallout of government persecution.

If conservatives call out the privilege of the Left's elites, we must ensure we aren't building a new class of our own.

When Bondi pledged to "back up Elon Musk every way we can," the defense was immediate. Musk didn't have to endure the years-long wait for justice that countless parents and citizens—smeared, investigated, or prosecuted for speaking at school board meetings or attending protests—still face.

Justice shouldn't be for "members only." The same transparency and accountability must apply to an ordinary mom or dad as to a billionaire. This is not about diminishing accountability for the powerful—it's about honoring the Republic's pledge of "liberty and justice for all."

Every citizen deserves equal access to truth and justice. That is why I co-founded Parents Demanding Justice Alliance (PDJA) with Sam Sorbo. We refuse to accept a tiered system of justice.

When leaders promise to "uncover how political power may have been weaponized," that pledge must reach beyond elite circles—to the parent ruined

by a false defamation claim, the small-business owner shut down for opposing government narratives, and the whistleblower who lost everything for speaking up. For most middle-class victims of weaponization and lawfare, justice is out of reach. Crushing legal costs, short statutes of limitations, and loopholes shielding officials block their path. Meanwhile, the government wields unlimited taxpayer-funded resources and elite lawyers to grind down any citizen who dares to fight back.

That's why PDJA is urging President Trump to sign our proposed Executive Order—restoring victims of Biden-era targeting and holding perpetrators accountable. Without it, abuses will go unanswered, paving the way for even greater political retribution.

Earlier this month, Bondi appointed Working Group head Ed Martin as special attorney to investigate Schiff and Letitia James. PDJA met with Martin in June on behalf of parents nationwide. On July 15, at a Capitol Hill press conference with Congressman Andy Ogles and Congressman Andy Biggs, advocates and targeted parents delivered our Dossier of Targeted Parents. Yet, no action has been taken. Their cries go unanswered, even as leftist activists double down with fresh waves of targeting.

Our Republic was “conceived in Liberty...,” meant to be a government of the people—not a system reserving justice for the powerful. If justice looks past the people to serve the elite, freedom becomes a gated privilege—and a Republic becomes an oligarchy of the elite.

America is better than that, and it's time we proved it. 🇺🇸

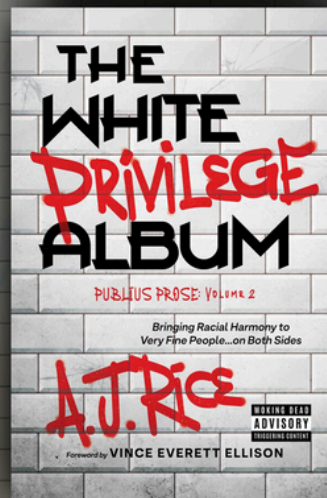

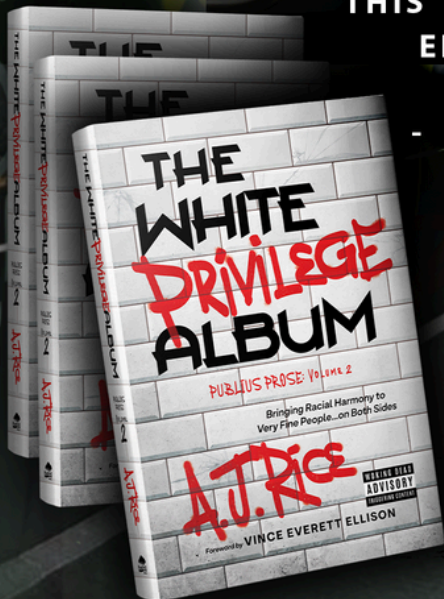

Each chapter of this thoroughly entertaining book is a “track” on this metaphorical album, and every song is a ringer. **Rice** takes aim at:

- **The DEI Industrial Complex**, exposing it as a corporate shakedown scheme with a rainbow logo.
- **Race Hustlers & Media Hall Monitors** who keep selling division like it’s going out of style.
- **The “Very Fine People” Hoax**, the Left’s favorite skipping track on their playlist of lying greatest hits.

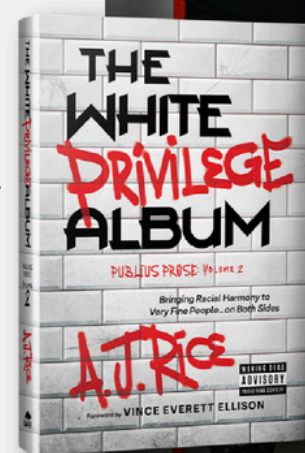

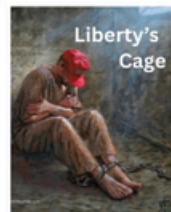

AMERICA'S CULTURAL REVOLUTION

Imagine a time when a dictator controls every arm of government—the police, the military, the media. Then rivals appear, and his grip weakens. Those institutions may no longer obey him fully. What tool remains to crush his enemies and reclaim power? The people themselves. Convince them they are righteous, identify an enemy, and unleash them. In the chaos, rivals fall, and control is restored—alongside the ideology the masses have been fed.

This was **Mao Tse-tung's Cultural Revolution**—a wave of political violence, persecution, and cultural destruction. As his authority waned, Mao bypassed the police, military, and courts, weaponizing the population against itself. Propaganda turned students into informants, children into torturers of their parents, and mobs into destroyers of centuries-old traditions.

That same playbook was used in America only a few years ago.

In May 2020, an ideology long nurtured on college campuses erupted nationwide. Cities burned. Ordinary people were assaulted. Statues fell. Anti-American sentiment poured through the media. Anchors described “fiery but mostly peaceful protests” while journalists and academics rushed to justify the unrest.

Violence was rebranded as the “voice of the unheard,” and glowing profiles of organizers filled the airwaves. Institutions that should have stopped the chaos stood down, choosing ideology over order.

They were biding their time. By January 2021, with political momentum in hand, they advanced to the next phase: openly institutionalizing the persecution of their political enemies.

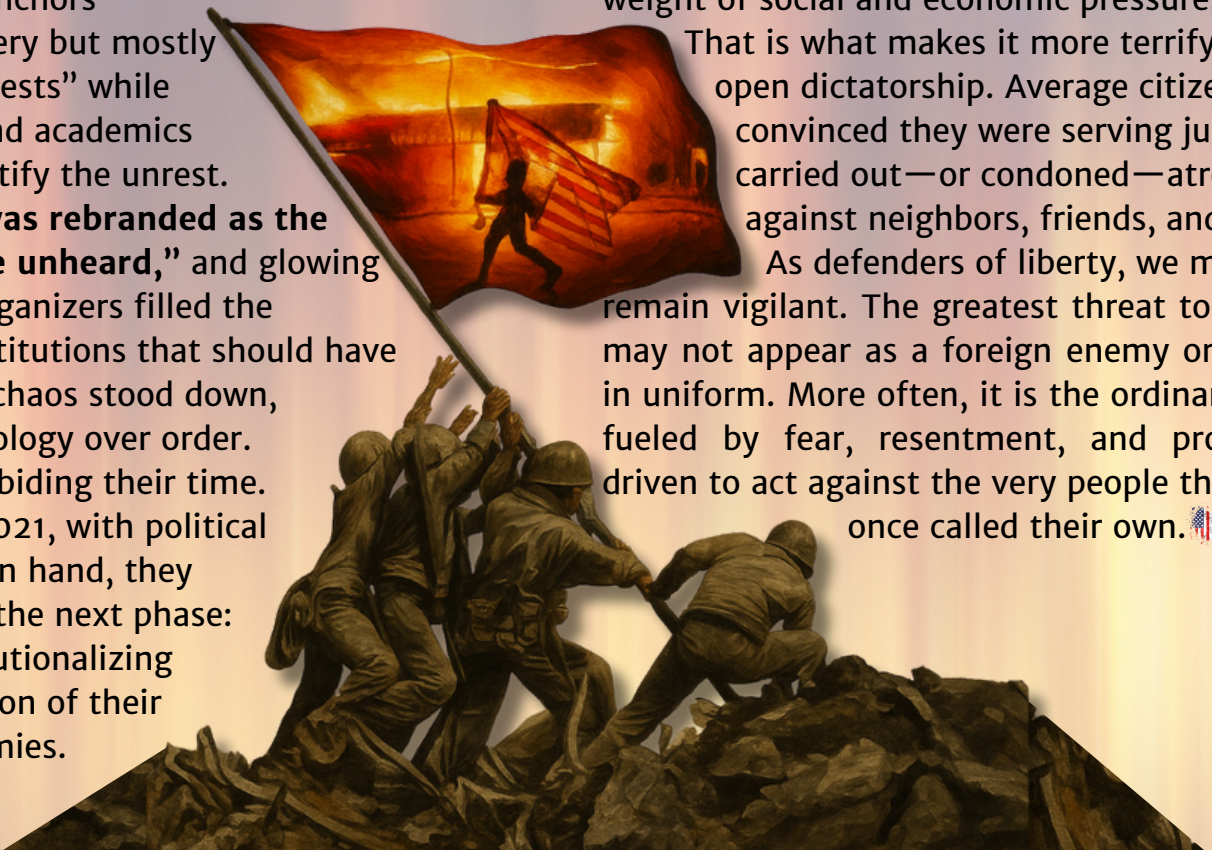
Federal law enforcement hunted down dissidents. Local authorities enforced lockdowns, barred people from dying loved ones, and silenced public dissent. Families fractured over politics and beliefs. Spouses turned on each other. Parents and children stopped speaking.

Private corporations joined the purge. Employees were fired over social media posts or skepticism toward an experimental vaccine. The President, backlit in crimson and flanked by shadowed guards, pounded a podium and warned defiance would be punished. **Fear became the “new norm.”** Even those merely unconvinced by the prevailing narrative were targeted.

This was not just government tyranny—it was culture as a weapon. The most effective force in that period was not a faceless bureaucracy but ordinary people, misled or malicious, enforcing ideological conformity. Families were torn apart, livelihoods destroyed, and individuals coerced into medical procedures—not at gunpoint, but under the crushing weight of social and economic pressure.

That is what makes it more terrifying than open dictatorship. Average citizens, convinced they were serving justice, carried out—or condoned—atrocities against neighbors, friends, and family.

As defenders of liberty, we must remain vigilant. The greatest threat to freedom may not appear as a foreign enemy or a tyrant in uniform. More often, it is the ordinary person fueled by fear, resentment, and propaganda driven to act against the very people they once called their own. 🇺🇸

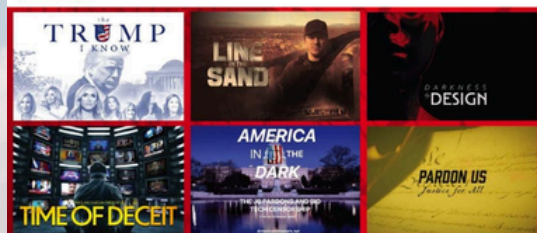
The audience rose in a thunderous standing ovation—an outpouring of gratitude and vindication for a woman many believe was murdered and then smeared by the very government she once served.

When is *Defying* the Law Justified?



In a shocking admission, Alachua County, Florida school board member Tina Certain bragged about breaking the law to keep sexually explicit books in public schools, declaring, “We live in a nation laws, but obeying the law ain’t always the right thing to do.”

America’s founders understood that the law exists to protect our God-given rights, and that unjust laws—those violating Higher Law—*should* be resisted.

They knew well these words by first-century Roman Orator, Cicero: “If the temporary masters of the state are unjust—that is, if they act contrary to the law of nature—men possessing right reason are under no moral obligation to obey them.”

Scripture is also clear: when man’s law contradicts God’s, “we must obey God rather than men” (Acts 5:29). Romans 13 commands submission to rightful authority, but not compliance with evil. Governing power is legitimate only when it serves as “God’s servant for your good” (Romans 13:4). When it violates the Creator’s Higher Law, resistance is not optional—it is required.*

But that’s not what this school board member was talking about. In their quest for cultural hegemony, the Left has twisted the valid justifications for civil disobedience, urging defiance, not of tyrannical laws, but of valid laws that safeguard parents’ natural right to direct their children’s upbringing. **It is a dangerous inversion: using the rhetoric of liberty to dismantle liberty itself.**

When leaders openly boast about breaking laws that protect parental rights, they are declaring war on the family. This is how far the education establishment will go—defying parents, defying the law, and daring anyone to stop them—all to advance an agenda that sexualizes children and undermines parental authority.

Defying the law is justified when tyrants make laws violating the Higher Law of Natural Rights, but laws protecting those rights must be upheld at all costs. 🇺🇸

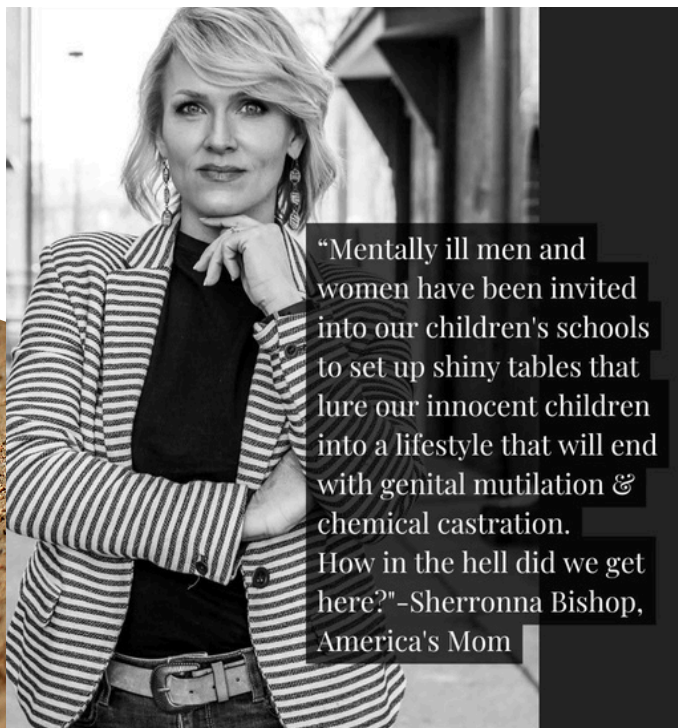

Outrage over the previous DOJ's "weaponization of government" appears to have reached a fever pitch. In one of his dismissal letters, FBI Director Patel argued that it was the FBI agent's "poor judgment" and "lack of impartiality" that led "to the political weaponization of government." [i] Unfortunately, this "weaponization" is merely a symptom of a much bigger constitutional issue.

Besides, the attempts at reform within the DOJ and FBI will easily be undone with the next Administration. **The only way to fix the "weaponization" problem permanently is to return to a strict fidelity to our Constitution's basic underlying principle of deconsolidation of governmental powers.**

The "general government" under the U.S. Constitution, Madison explained, was not "a consolidated government." If it had been consolidated, he continued, its "power and authority would extend to all cases" and "usurpation might be expected to the fullest extent." [ii] In other words, the Framers gave us a Constitution where government's powers were severely limited. Over the last 150 years or so, our politicians and judges have been undermining this basic, fundamental, constitutional principle to the point where it no longer exists.

As such, we have become nothing more than a "spectacle of turbulence and contention" [iii] where politicians hypocritically extol the virtues of a society governed by the supposed "rule of law," while they ignore the "Supreme Law" of the land. **Originally, our U.S. Constitution created a Federal Government with very few and defined powers.** Today, however, our U.S. Constitution has become nothing more than a façade for a consolidated Federal Government.

Under our U.S. Constitution, Madison explained that the nation would be "broken into so many

parts, interest and classes of citizens, that the rights of individuals” would never be in danger of oppression.[i] However, **when government consolidates unwarranted powers, there is nothing that can stop it from attacking its own citizens much like we saw during the Biden Administration.**

Alexander Hamilton echoed this sentiment —“An entire consolidation of the States into one complete national sovereignty would imply an entire subordination of the parts; and whatever powers might remain in them, would be altogether dependent on the general will.”[ii] This is where we are today. The states are mere vassals of the Federal Government because it has consolidated states’ powers in direct violation of the Tenth Amendment.

Madison put it this way—“The powers delegated by the proposed Constitution to the Federal Government, are few and defined. Those which are to remain in the State Governments are numerous and indefinite.”[iii] Madison then went on to spell out those “few and defined” powers so as to leave no room for speculation. The Federal Government’s powers, he explained, “will be exercised principally on external objects, as war, peace, negotiation, and foreign commerce.”[iv]

Notice that Madison’s list did NOT include anything like education, health, the environment, medicine, the economy, alcohol, tobacco, firearms, drugs, and everything else the Federal Government regulates today. All of these internal objects, Madison went on to explain, were reserved for the states, whose powers “extend to all the objects which, in the ordinary course of affairs, concern the lives, liberties, and properties of the people.”[i]

In the vernacular of Hamilton, “there is not a syllable”[ii] in our U.S. Constitution which directly empowers the Federal Government to regulate any aspect of our daily lives, beyond protecting us from external dangers. Outside of enforcing our borders, regulating international commerce, and handling disputes between the various states in the Union, there is very little power that the Federal Government is legitimately authorized to exercise under our Constitution.

What the D.C. crowd says, while talking to us from behind their “specious masks” so as to hide “their dangerous ambition” which is “the introduction of despotism,”[iii] you should not believe any of it. **The hard cold FACT is that there is no authorization in our Constitution for the Federal Government to regulate our education, our healthcare, and everything else they have their hands on today.** Their only real, constitutionally authorized job is to secure and protect our borders from invasion and to fight our Constitutional wars. Everything else is left to the states under our Constitution.

Unfortunately, we’ve allowed our government to consolidate powers reserved to the states. This is the real reason we have what is now being called the “weaponization of government”. The Framers used a much different word to describe this phenomenon —“The accumulation [or consolidation] of all powers...may justly be pronounced the very definition of tyranny.”[iv]

Until we fix the consolidation problem, none of the reforms in the DOJ or the FBI will ever have a lasting, permanent impact on our liberties. We have to return to the basic principles of deconsolidation of governmental powers, if we are truly serious about stopping the tyranny in D.C. for good. 🇺🇸

The Rights They Hope You've Forgotten

The Ninth Amendment & the Fight Against Government Weaponization

In the America our Founders envisioned, government was meant to be the servant, never the master. But in the shadow of Biden's weaponization against citizens, that principle was shattered. Federal agencies targeted political dissenters, concerned parents, and whistleblowers with investigations, public smears, and prosecutions designed to intimidate and destroy.

Our nation has never faced such extreme state-sponsored repression. And though Donald Trump now holds office, **the long shadow of this domestic persecution still looms—unchecked in some cases, and even worsening where it has gone unaddressed.**

The same arrogance driving these abuses justified the COVID-era decrees, mandates, and orders—a belief that rights are “granted” by government. The truth is far older and far deeper: your rights are Natural Rights—God-given, pre-political, and beyond the reach of any administration.

That truth is enshrined in the often-overlooked Ninth Amendment, which

safeguards a “realm of personal liberty which the government cannot enter.”

James Madison and the Framers knew the Bill of Rights could never fully enumerate the vast field of freedoms the people inherently possess. The Ninth was their shield against those who would exploit any “unlisted” right as an open door for tyranny.

Legal scholar Daniel A. Farber put it plainly: the Bill of Rights was “illustrative, not complete.” **The Framers saw Natural Law as hard, enforceable law—not a decorative ideal.** Madison warned that without the Ninth, federal power could consume every right not explicitly written down, a list that by nature could never be complete.

Among those unenumerated rights is the sovereign authority of parents to direct the upbringing, education, and moral guidance of their children. That's not a privilege—it's a Natural Right predating any form of government. Our sons and daughters are not “mere creatures of the state” to be molded by bureaucrats—they are entrusted to us by God. Yet in some school districts, the oppressors are doubling down, pushing radical policies and finding new ways to shut parents out of decision-making.

The same mentality drives today's broader weaponization: if they can sidestep our Natural Rights in one area, they can sidestep them anywhere—raiding homes, freezing accounts, prosecuting political opponents, and defaming citizens to silence dissent.

For most victims, legal remedies are out of reach. They are blocked by the crushing cost of litigation, short statutes of limitations, and legal loopholes designed to shield officials from accountability. Meanwhile, the government's arsenal includes endless taxpayer-funded resources and powerful lawyers who can grind down any private citizen daring to fight back. This imbalance of power means that, for thousands of Americans, justice is not just delayed—it's impossible under the current system.

That's why PDJA is urgently pressing for our proposed Executive Order—a decisive step to restore the victims of Biden-era targeting and ensure perpetrators face real consequences. Without such action, these abuses will remain unresolved, setting a precedent for even greater violations when the next wave of political retribution comes.

Millions of Americans have already been targeted and politically persecuted for reasons ranging from matters of faith and political beliefs, to simply defending their children. The present administration's failure to act decisively is emboldening these abusers, signaling that there will be no consequences.

If we do not hold the perpetrators accountable now—and in some cases, make arrests—they will return to power with even greater determination to crush their opponents and strip away our most fundamental liberties.

Justice delayed is justice denied, and every day without action only emboldens the leftist bullies. We remain confident, however, that the President will stand with the American people and take decisive action to end this abuse once and for all. 🇺🇸

THE EXONERATION OF KIRK MOORE AND THE TRIAL OF PAM BONDI

Dr. Mike Moore's exoneration represents a victory not just for one man—but for conscience, autonomy, and resistance to state overreach. His case embodies the essence of freedom: **the moral right to act when laws themselves are unjust.**

DOJ Charges Against Dr. Moore

In January 2023, during the height of COVID-19 mandates, the U.S. Department of Justice—then under AG Merrick Garland—indicted Dr. Michael Kirk Moore, a Utah plastic surgeon, along with his medical corporation and three co-defendants. He was accused of:

- Conspiracy to defraud the United States, for issuing nearly 2,000 fraudulent COVID-19 vaccination record cards without administering vaccines.
- Conspiracy to convert, sell, convey, and dispose of government property—allegedly destroying over \$28,000 in government-issued COVID-19 vaccines.
- Administration of saline injections to minors, at parental request, so children would believe they had been vaccinated.

Although Dr. Moore pleaded not guilty, federal prosecutors sought penalties totaling up to 35 years in prison.

Trial and Mounting Support

The trial began in Salt Lake City in July 2025. Outside the courthouse, crowds rallied, waving signs like **“Dr. Moore is a hero, not a criminal,”** while Utah lawmakers denounced the prosecution as **federal overreach.**

Support poured in from prominent voices such as Representative Marjorie Taylor Greene, Senator Mike Lee, and even Health Secretary Robert F. Kennedy Jr.

Attorney General Bondi Steps In

Just three days into the trial, AG Pam Bondi intervened, instructing the DOJ to dismiss all charges. She publicly declared, **“Dr. Moore gave his patients a choice when the federal government refused to do so. He did not deserve the years in prison he was facing. It ends today.”** The dismissal was officially filed **“in the interests of justice.”**

Dr. Moore's journey from prosecution to exoneration highlights freedom's foundational values:

As these events unfolded, the state itself reaffirmed that coercive policies—such as forced vaccinations—have since been found unconstitutional or overturned through court challenges.

My Friend Charlie

Where do we start?

Charlie and I shared endless humor and teasing. We quoted Seinfeld constantly—he knew the show better than I did. That was Charlie: brilliant, quick, and full of life.

I was at the gym when I got the text I could not imagine. It hit me like a punch. I sat with my head in my hands and wept. **My friend Charlie is a martyr. He was murdered for his faith in Jesus**—killed by forces that hate truth, love, and God.

I met Charlie when he was 24, with his fiancée Erika, now his widow and the mother of his children. Over burgers in Manhattan, he told me my books had inspired him.
