The Mission of Tim Ballard and TBFRescue



In the landscape of modern human rights, few shadows are as haunting as human trafficking. Today, it is a \$150 billion global industry—the fastest-growing criminal enterprise in the world. As Tim Ballard often points out, there is a chilling distinction in this trade: unlike drugs, which are sold once, a human being can be sold dozens of times a day.

To combat this, Tim Ballard and **TBFRESCUE** (The Tim Ballard Foundation Rescue) operates on a global mission to dismantle exploitation through strategic rescue operations, digital forensics, and survivor aftercare. Tim's work takes him from the front lines of the U.S. border to the most volatile regions of the Middle East, South America and globally. By partnering with local law enforcement and vetted NGOs, TBFRESCUE provides the intelligence necessary to break rings that often operate in plain sight.

The Hidden War at Home, Trafficking is not a distant problem; the United States remains one of the world's top destination countries and a primary consumer of child exploitation material. This is the focus of the new film, **Hidden War**. It is an eye-opening call to a battle the world would rather ignore, exposing the corruption and spiritual warfare that feed modern-day slavery. It is a story of the rawest side of crime, but also the incredible courage of those who face it.

Beyond the Rescue a central pillar of the TBFRESCUE philosophy is that rescue is only the beginning. True restoration requires honoring the inherent dignity of survivors through trauma-informed care and moral clarity. We focus on:

- **Safe Recovery:** Fostering healing in safe spaces through global partnerships.
- **Family Restoration:** Reuniting children with safe family members or facilitating adoption to ensure they are never vulnerable again.
- **Empowering Survivors:** Seeing those who were once saved grow to become anti trafficking operatives themselves.

Human trafficking thrives in the dark, but it cannot survive the light of truth. This mission isn't about politics or hidden agendas—it is about the children caught in the crossfire. It is our duty to protect the vulnerable.

When we eventually meet our Maker/God, we want to be able to say we did everything in our power to rescue His children. We invite you to join us in this fight to stop modern day slavery and bring the children safely home.

Hope Blooms in the Filth

My Journey to Child Trafficking Awareness



Like many of you reading this, I had a nebulous notion that children were sexually abused—everybody knows adults with stories about having been molested, raped or harassed.

But my first exposure to what we used to call “child prostitution,” and now refer to as “child sex trafficking,” or just “human trafficking” became real to me at the tender age of just twenty years old. As a college student, I volunteered a year of my life to teach teens and young adults at a school in the hill country of Nuwara Eliya, Sri Lanka.

One fine, warm tropic evening, another student and I were walking along the beach in the capitol city of Colombo, enjoying the sound of the waves and the waning light of the setting sun. Along came a man, who we assumed was going to ask for money or had something to sell—as we experienced everywhere we went.

The conversation went something like this:

“Hello, sirs! You want women? I get you women...”

“No! No!”

“You are German...American..?” You want little girl? I bring little girls.”

“No! Yanna! (යන්න: go away!)”

“Ahh...what about little boy?”

At this point, my friend Tom and I *chased* the creep away!

As a young, wet-behind-the-ears student of Theology, English, and ESL, teaching overseas, I was shaken by this encounter. I thought perhaps this was a third-world thing, a byproduct of families so desperate for money they would prostitute their own children.

I did not yet understand the full scope of the unspeakably evil, worldwide abomination.

Flash forward to about 2008, when I had the opportunity to visit Nicaragua for the first of two visits (I speak fluent Spanish). On this first trip, I went with a group to visit a school and community in *La Chureca* in Managua: the largest landfill in Central America. The term *chureca* means more than garbage, and something more like “filth”; it carries strong associations with poverty, degradation, and abandonment. If you wanted to find the modern day embodiment of *Les Miserables*, this was it. And the filth wasn’t just garbage...

We made the rounds in the community where shanties were literally made of *basura* (garbage), and I served as one of two translators.

One woman I spoke to told me that she prayed every night for a piece of plywood to use as a roof, terrified that the jumbled trash composing her family's "roof" would collapse in a storm and crush them. She told me stories of roving gangs that stalked the clusters of shanties to abduct and rape children; she related the community's inability to adequately protect their own families.

Later in the trip, our group spent a day with young street boys addicted to "huffing" glue to get high as a way to temporarily escape the horrors of poverty and abuse. This *pegamento* was very cheap and ubiquitous; its use caused brain and body damage and could be fatal.

We learned that many of these boys were routinely sodomized in the street—no wonder they self-medicated! Younger children often disappeared completely—and you can fill in the blanks.

We took the boys to the crater lake, *Laguna de Apoyo*, to swim and give them time just to be exposed to good role models and healthy love and compassion. One young man in particular, about 16 or 17, gravitated to me—that is to say, he never left my side. He called me *papa* throughout the day.


As we pulled the bus back into the city to drop the boys off at a center, he asked for my tank top to remember "papa" by.

"*Pero, mijo, esta sudado y huele mal!*" (But, my son, it's sweaty and smells bad!) I said.

"*No me importa si huele de mierda,*" he responded. "*Qiero la camisa, por favor!*" (I don't care if it smells like sh-t...I want the shirt, please!)"

Heartbreaking and endearing all at once.

In 2010, I met the beautiful young woman who was to become my lovely wife. As we were dating, she began talking about an issue of great concern to her: child sex trafficking. As I recall, my first reaction to her exposing the extent of the problem through websites, books and discussions was that I wanted to hunt down these monsters and rescue the children.

She told me that many people have that reaction initially, but the problem is so widespread and systemic, that a much more comprehensive approach was needed.

In 2024, we learned another way traffickers get children after my family took in a little boy named Henry, fostering him while his mother, Felicia, reported to prison for the act of walking in the People's capitol.

Shortly after that historic day when patriots protested against 2020 election irregularities, David Sumrall of StopHate.com had asked if we would host a baby shower for Felicia at our Tucson coffee shop—(which was later seized by armed men working with a corrupt city and county after I stood up for Pima County children.) By 2024, Henry was a toddler and had no safe placement. Had we not intervened, CPS would have taken him, and local pedophile hunters warned he was at serious risk of being trafficked across the border.

Despite severe financial strain—and after being targeted by Merrick Garland’s DOJ in 2021 for speaking out for schoolchildren—we stepped in. With three young children of our own, we prepared to raise Henry for up to four years. By God’s mercy, the judge intervened, and Henry remained with us for several months. To this day, when his mother shows him photos from that time, I am still “Daddy,” and my wife is “other Mommy.” The full story, “Saving Henry,” appears in the December issue.

Now we come to the present day, and I am humbled and grateful to produce this issue of *FreedomTalk Magazine*, dedicated to making you more aware of this scourge—this national and international sin that must be eradicated, no matter what it takes—and in pursuit of legislation and funding to help those who’ve devoted their lives to making that a reality.

And I hazard to say, as that guy with a theology degree and a heart for God that I do not believe this nation will be spared from judgment and catastrophe if these “little ones” do not receive justice and liberation. You may as well hang a millstone around the neck of each and every person who turns a blind eye and a careless heart. Up to 750,000 Americans died in the Civil War as a result of this nation participating in the age-old practice of human bondage.

How much more destruction may come if we allow children (and adults too) of all colors and nationalities to be used and discarded for the lust of wealthy monsters (you know some of the names).

Dr. Robert Renteria grew up in “the Barrio” in conditions most “polite” people would like to avoid. Drawing from his own journey—growing up poor in East Los Angeles, surviving violence, navigating gang culture, serving as a U.S. Army Airborne Veteran for over seven years, and rising into corporate America—he presents young people with something rare: an honest account of consequences paired with a credible path forward. His central message is simple but demanding: education is the great equalizer, character is destiny, and your past does not get to dictate your future.

For more than two decades, Dr. Renteria—author, civic leader, and founder of the From the Barrio Foundation—has built a culturally relevant, bilingual body of work that meets young people where they are, while refusing to leave them there. His flagship book series, *From the Barrio to the Board Room*, along with companion works, the graphic novel *Mi Barrio* and the activity coloring book, *Little Barrio*, form the backbone of an integrated educational and mentorship program now used across the U.S. and in more than 25 countries.

Today educational “reforms” too often treat children as data points and communities as problems to be managed. Dr. Robert Renteria offers something radically different: truth rooted in lived experience, education grounded in character, and hope forged through responsibility.

What distinguishes the Barrio curriculum is not only its content, but its method. While modern education systems lean heavily on standardized testing and quantitative metrics, Renteria’s program emphasizes qualitative assessment—critical thinking, self-reflection and moral reasoning, as students engage through discussion, writing, performance, art, and peer mentoring, producing real-world evidence of growth that numbers alone can never capture.

This approach has proven especially effective with at-risk youth. The Barrio books and curriculum are now used in middle schools, high schools, colleges, juvenile detention centers, prisons, probation programs, shelters, churches, and community organizations—often reaching young people who have already been written off by the system. **8**

Rather than lecturing students about abstract virtues, Renteria challenges them to examine choices, consequences, identity, friendship, work ethic, and leadership through guided reflection and peer dialogue.



Importantly, Dr. Renteria has ensured that both the academic-based and faith-inspired curricula are donated at no cost to educational institutions and youth organizations. His stated goal is nothing less than to exchange books for guns, knives, drugs, and despair; to replace cycles of violence with literacy, discipline, and hope.

The impact has been widely recognized. Dr. Renteria has received multiple international honors, including an honorary doctorate for leadership and humanitarian work, two national Dr. Martin Luther King Jr. Awards, and global recognition from organizations such as the World Boxing Council, which appointed him a Youth Ambassador representing children in 176 countries.

Yet perhaps the most compelling evidence of Barrio's success lies not in awards, but in transformed lives—students who begin to see themselves not as victims of circumstance, but as stewards of their own future. While many institutions seem intent on lowering expectations, Dr. Robert Renteria raises them, and then walks alongside young people as they rise to meet them.

Renteria's work does not sanitize hardship, nor does it glorify it—it challenges young people to use it as a catalyst for growth and a challenge to rise above circumstances.

For educators, parents, pastors, civic leaders, and anyone concerned about the moral and educational direction of the next generation, the Barrio project stands as a living reminder: real reform does not come from bureaucracy. It comes from truth, responsibility, and the courage to believe that every child—no matter which barrio or ghetto they come from—was created for more.

THE SHADOWS BETWEEN SOFTWARE AND THE WORLD: WHERE TRAFFICKING HIDES

Human trafficking is the darkest crime of our age because it rarely looks like chains. It looks like paperwork, a placement, court order, guardianship or a “service provider”; a file stamped “resolved” while a human being is still missing. Trafficking hides in plain sight, the modern mechanism is not only force, it’s fraud that becomes “official” the moment a compromised record system blesses it.

That is where Toll and Roll™ comes in. We are a national delegation built to audit what I call the web of deception: public records, court orders and software systems that turn paperwork into power. We bring documented evidence, delivering a legislative remedy designed to restore integrity, recover stolen assets, and shut down the pipelines of child trafficking. You can review the proposed legislation at www.tollandroll.com. Our proposed legislation is The People’s Remedy and Restoration Act—The New Declaration of Independence 2025 (PRRA).

PRRA is written to do what task forces and headline hearings rarely accomplish: put proof back into the process, require auditable records, and impose enforceable responsibility when records are forged, manipulated, or monetized. Trafficking thrives wherever institutions can move children, money, and rights without verifying reality. This is why Title IV child welfare systems are a hot-button issue. When funding follows administrative pathways, the risk is not abstract. Paper compliance becomes a shield for harm.

A child can be moved, reclassified, or lost in the gaps while the system continues to run on autopilot. Predators don’t need to defeat the law when the law has been reduced to forms, vendor platforms, and rubber stamped orders. Our delegation’s January 2026 trip to

Washington, D.C. reinforced a hard truth: reform often dies at the “intake desk” long before it reaches senior review.

We delivered binders that included PRRA, preamble, seven supporting Acts, and a Title IV white paper written to show, plainly, how the remedy applies without rewriting programs. We followed up with multiple offices, including Senator Grassley’s Judiciary oversight staff and Congress members Clay Higgins and Marcy Kaptur’s teams. We also held substantive appointments with Congressman John Carter’s office and Congressman Michael McCaul’s office. We continued engagement with DOGE: our delegate Matt Skarlatos hand delivered the requested evidence package ahead of our May 2 meeting, including what we calculate as enormous recoverable fines and fees. Since then, DOGE counsel has limited further meetings while continuing to accept submissions, and multiple congressional teams requested our DOGE packet, a process that may signal scrutiny, but isn’t a substitute for bill sponsorship. Let me say this clearly for *FreedomTalk Magazine* readers: this is not just about trafficking “out there.” It’s about whether Americans will accept a country where systems can be used, under color of law, to strip a person of home, children, property, and due process. If you want to find trafficking, look for the points where fraud becomes authorized, where records replace truth, and where citizens are denied meaningful review while institutional and unelected bad actors hide behind procedure. The remedy isn’t more theater, it’s enforceable structure: audit authority, record integrity, independent oversight, recovery, restitution, and criminal referral where evidence demands it. That is what PRRA is built to do.

The 1A Film Fest 2024 World Premiere of *This Is Treason: Trafficked*, from filmmakers retired Border Patrol Agent and author J.J. Society can only be healthy and functional when consequences serve as a deterrent to deviant behavior and cartel operations.

The Grooming Pipeline: Why Parents Who Resist Keep Getting Targeted



On a recent broadcast of WINN Tucson on 1030 The Voice, host Kathleen Winn welcomed Seak Smith and Kelly Walker to discuss an issue that is no longer theoretical for American families: the steady dismantling of boundaries that protect children, followed by the punishment of any parent who objects.

Smith, founder of Mom & Dad Army, made clear where her organization stands. They “specifically sit in the lane of protecting children’s innocence from sexual abuse and trafficking.” That distinction matters. The public-facing language around these issues often centers on “education,” “inclusion,” or “tolerance,” but parents on the ground are seeing something far more dangerous— institutions conditioning children to accept adult themes and secrecy as normal, while pressuring moms and dads to remain silent.

Winn cut through the euphemisms. “We know what’s right, we know what’s normal, we know what’s acceptable—and there’s this boundary that the other side keeps pushing,” she said. Then she made the point many officials refuse to acknowledge: “This shouldn’t be political. Everyone should want to protect the innocence of children.”

Grooming Begins with the Erosion of Boundaries

Grooming is not a single act, but a process. It begins by dulling a child’s instinct that something is wrong and reshaping the adult world around them until the abnormal feels routine. Smith described the pattern plainly:

“You’re having this normalization of targeting children...as easy targets...as vulnerable victims to predators.”

That reality is rarely discussed in policy debates, but it is well understood by anyone who works with trafficking survivors.

Sexual exploitation thrives where boundaries are blurred, where sexualized material is introduced early, where secrecy from parents is encouraged, and where adults who object are labeled as dangerous or extremist.

Winn underscored how basic—and how outrageous—these violations have become. Referencing a news story mentioned during the program, she said, “They’re prosecuting a teacher...that encouraged young girls, in a vulnerability exercise, to take their clothes off. Like, come on. Like, stop.” It was a reminder that lines once considered unthinkable are now being crossed openly.

Retaliation is Methodical

Perhaps the most revealing part of the discussion was not the incidents themselves, but what happened to the parents who intervened.

Smith shared a public case from Southern California involving an all-ages drag queen story hour reportedly tied to local government sponsorship. According to Smith, a nearby preschool planned to bring “three and four-year-olds” to the event “with no notification to the parents.” When one mother learned of it, she mobilized other parents and helped get the event canceled.

The response was swift and punitive. “She lost her job immediately—within days,” Smith said. “An investigation was opened on her,” and the fallout spread to her finances and reputation. “Her credit was ruined,” Smith explained, adding that the damage took years to recover from.

That kind of retaliation sends a message far beyond one family. When a parent is financially and professionally destroyed for speaking out, the goal is to protect the abusers through fear and intimidation.

As Winn put it, “All she did was tell the truth.”

Another case involved a father in the U.S. Navy who attended a school meeting and asked a simple question: if his elementary-aged twins attended a school-sponsored LGBTQ club, would he be notified? “That’s really all he asked,” Smith said.

What followed was all too familiar. He was publicly smeared, investigated, and labeled with ideological slurs. According to Smith, he was called “a white supremacist...and every name in the book,” simply for asserting his role as a parent.

This inversion is central to the grooming pipeline. By instituting policies and legislation that treat parental awareness as a threat, the system protects the groomers.

Walker, working alongside Seak Smith, Alex Newman and others through the Parents Demanding Justice Alliance, has been collecting these cases and demanding accountability for the DOJ-led targeting of parents who spoke up in good faith. He referenced the October 4, 2021 Justice Department memo that treated parental dissent as domestic terrorism and explained how that precedent plus federal collaboration weaponized state and local systems.

Winn closed the discussion with a warning every parent should take seriously: “Don’t ever back down. If you think something’s happening, trust your gut.”


The grooming pipeline depends on intimidation. It grows when parents are isolated, shamed, and silenced. If communities are trained to fear retaliation for speaking up, children become easier to exploit.

To ensure that fear only stalks the predators, the innocence of childhood must be protected by parents and advocates who refuse to be intimidated.





When the Wicked Rule, The People Mourn

The disease of human trafficking infected this country long before it was ever formed.

Unfortunately, far too many people today hurl the disease of human trafficking at the Founders to try and infect their good, moral characters. Human trafficking was already a deeply entrenched culture which Washington and the rest of the Founders inherited. They did not create it. They were born into it, and they were the ones responsible for the demise of the trafficking of African slaves.

This historical truth has been lost to our nation's collective memory all in the name of progressivism. As a whole, we have forgotten that the Founders came together to form a better society and NOT just a different one, and they were willing to sacrifice all of their inherited wealth to do it. The Framers of the Constitution are the reason the human trafficking of Africans stopped. They were NOT the cause! The Founders were born into a culture that had been foisted upon them by the politically corrupt British Crown. More significantly, it should also be noted that the Founders actually changed their culture without slaughtering millions upon millions of innocent people in order to effect political change.

History clearly shows that with the one, rare exception of our Founders, whenever a society has tried to throw off the old norms in order to replace it with a new one, blood has always flowed in the streets—think French and communist revolutions for starters.

Thomas Jefferson is one who has been maligned on this topic, but he also inherited the culture. He was a key figure in laying the groundwork to rid our Country of its evils. He explained this historical fact and the insurmountable task that the Colonists had been up against in “A Summary View of the Rights of British America.” This piece was written in 1774 by Jefferson—two years before the Declaration of Independence—and proves that **he and the rest of the Founders had been trying to rid the colonies of human trafficking for some time:**

“The abolition of domestic slavery is the great object of desire in those colonies, where it was unhappily introduced in their infant state...**yet our repeated attempts to effect this by prohibitions, and by imposing duties which might amount to a prohibition, have been hitherto defeated by his majesty's negative.**”[i]

Jefferson and the rest of the Founders had actually been trying to stop human trafficking long before 1776 with tariffs but were unable to do so because of the British Crown. Thanks to all of the revisionists out there, however, this historical fact has been lost to our collective national conscience. **It is also amazing how many conservatives do not understand the herculean task at national transformation which George Washington and others forged by throwing off one country's entrenched culture to form a new one without all of the bloodletting.**

It was the corrupt government of England that introduced human trafficking into the Colonies and kept it going, NOT the Founders. It was the corrupt government of England that prohibited the abolition of slavery in the Colonies, when the Colonists tried to stop it by imposing tariffs on their human trafficking.

It is a historical fact that the wisdom and courage of the Founders that culminated in the establishment of the Constitution was the impetus for the termination of the evil practice of human trafficking. Madison explained it this way when discussing the “many objections against the new Constitution.”[ii] Human trafficking would end under the Constitution, Madison declared, when responding to those detractors who argued that the importation of slaves should end immediately instead of waiting for another 20 years after its adoption—“Is the importation of slaves permitted by the new Constitution for twenty years?” Madison asked, “By the old it is permitted forever.”[iii]

In an attempt to shame the Founders, the revisionists are always quick to point out that the British were the first to outlaw slavery, in 1833, some thirty years before we were able to stop it completely. In all seriousness, though, this was the very least the Brits could have done considering they were the instigators and facilitators of human trafficking in so many areas across the globe. The real challenge was here in the Americas and not in Britain, since we were the ones who had to clean up the filthy, dirty mess they left behind.

Without our break from England, and, more importantly, without the Constitution, which exists because of the Great Compromise, the human trafficking of Africans most certainly would have continued on forever here in the New World and we would still be subjected to the Crown.

Today we are, once again, facing our own monumental moment in this regard and, just as in 1776, we are suffering under a corrupt government that no longer adheres to the U.S. Constitution.

Like the British Crown our own government has been facilitating human trafficking across our own borders. Following the unprecedented release of millions of pages of documents surrounding **the Epstein files**, one political commentator exclaimed “We were RIGHT! A satanic child eating pedophile ring in D.C. does exist!”[iv] Such revelations mean that we cannot trust the corrupt, spineless, compromised politicians in D.C. to fix this generation’s human trafficking problem.

The Founders have no equal in D.C. They laid the foundation for the deconsolidation of government in a world that only knew consolidated government, such as the British Monarchy, but we have migrated back towards consolidated government once again. The U.S. Constitution created a very small government with very limited powers where the national government had basically one task and that was to protect our borders. As consolidated government continues to grow in scope and power so does the corruption.

Until we get back to limited government with limited power, we will never be able to eradicate the current evils of human trafficking from our society. Any and all efforts will be as futile as the pre-revolutionary efforts of the Founders to stop trafficking in their day. **The heavily redacted release of the Epstein files speaks volumes about this truth as does the vilification of the few Republican members of the House who pushed so hard for the release of those files.**[v]

WEAPONIZING CHILDREN

AN AGELESS TACTIC

With as quickly as the news cycle continues to move, it's easy to lose track of individual stories that cross our feeds. There's hardly enough time to read a situation from multiple viewpoints, much less analyze it critically. Much to our detriment, this means that we will miss many of the patterns that emerge within the news and likewise the chance to study and understand the tactics of differing political factions. One example of this is a recent news story of a 5-year-old boy that ICE "arrested," to hear the Left tell it. Naturally, it quickly came out that the father had abandoned the child, and ICE took him in, buying him a Happy Meal while they attempted to contact other relatives. But as the saying goes, a lie can travel halfway around the world before the truth can get its boots on. The tactic of using child trafficking and weaponized empathy is far from new, however. It has been used by evil people for evil ends since the beginning of time.

One of the first instances of the use of children for evil ends on a massive scale is of course, the ancient records identifying the mass sacrifice of infants and children to Moloch by pagan barbarians in the time of the early Old Testament and beyond. Another example of the savage, wicked use of children in the historical record is the practice of the Ottoman Turks in the 1300s, in which the Ottoman Empire began a practice of kidnapping Christian children from the lands that they raided and conquered.

Specifically, they would kidnap the strongest young boys, whisk them away back to their lands, and begin a regime of religious brainwashing, sexual abuse, and martial training for years on end. The result was a caste of fanatical shock troops to be thrown into battle to slaughter their own people and families in Christian lands on behalf of the Turks.

The Turks referred to these troops as Janissaries, and they terrified Christian warriors for hundreds of years. The logic was simple: while the European Christian warriors would hesitate to kill their own kin on the field of battle, the brainwashed, fanatical Janissaries would suffer no such indecision.

It is interesting, then, to note that these ancient and medieval customs of wickedness are reflected in and indeed make up a central part of the policy platform of the modern Left. The Child Soldier America Helped Traffic



There's no doubt that child trafficking and exploitation rank among the top evils in the world. It's a crime that strips innocence, dignity, and life itself. And tragically, America isn't just a victimized nation in this fight; it's become the leading land where this evil thrives.

We often hear about American children who are kidnapped, sold, or worse. But today, I want to draw your attention to something we rarely acknowledge: children who aren't born here, but are smuggled through our borders, used, erased, and forgotten. The United States is not just the end of the trafficking line. It's the transition point.

I'd like you to meet Ray Torabi. Ray was born in 1982 in Iran's Evin Prison, where he spent his first year with his mother. His parents were jailed for opposing the Islamic Republic. After they were released, they fled to Iraq right into the arms of the MEK, a group they believed was fighting for freedom. In reality, MEK, aka PMOI, NCR, and NCRI, is an Islamist-Marxist terrorist cult with a long track record of terror, violence, deception, and totalitarian control.

By the time Ray was 7, his parents were full members of MEK's armed branch, stationed at Camp Ashraf, a massive military compound funded by Saddam Hussein.

Ray and nearly 1,000 other children were separated from their parents, placed in

MEK-controlled daycares and schools, and only allowed weekend visits. But when the Gulf War hit in 1991, those visits ended. MEK implemented a "mandatory separation" policy; parents would remain as soldiers; children were smuggled out. Ray, just 9 years old, was moved from Iraq to Jordan, flown to the U.S. with forged documents, then taken across the Canadian border. There, he lived in foster homes for nearly eight years, without a passport, legal status, or access to his parents. When he asked about his father, they lied: "He's on a secret mission. He can't talk to you." When he asked to speak to his mother, they said it wasn't possible.

At age 16, a woman from MEK came to him in Canada and asked a question no child should have to answer: "Do you want to see your parents?" Ray said yes.

MEK smuggled him from Canada into the U.S. He was kept there for nine months to raise funds under false pretenses. He was sent on fundraising trips to Colorado and Los Angeles, including staged charity drives at LAX airport. When they were done using him, they smuggled him out of JFK Airport with a fake passport, flew him to Jordan, and drove him into Baghdad. That's when they turned him into a soldier.

There were nearly 200 other child soldiers in the same situation, all trafficked, all lied to, all militarized. Some were as young as 13. Ray received full military training: pistols, AK-47s, anti-aircraft weapons, and tanks. He lived in a militarized compound ringed with barbed wire and watchtowers, not to keep enemies out, but to keep children from escaping.

He spent 18 years inside. Not just surviving, but working their system: finances, politics, recruitment. He saw the real face of the cult: staged martyrdoms, donation scams, and ritualized psychological control.

Ray learned that his father was tortured and killed by MEK, a fact later confirmed in a [Human Rights Watch](#) report. His mother, still in the cult, told him that if he left, he would be dead to her. He left anyway.

Ray now lives in Germany. He's married. He's a father. And he's not hiding. He speaks out because, in his words, "When it comes to MEK, the best defense is a good offense. Speak up. That's the only way to survive."

MEK leaders use [American media](#), [politicians](#) from both parties, though mostly [Republican Party](#), to launder their image, all while exploiting trafficked children. Some are paraded in fake fundraising schemes for nonexistent causes. Others are trained as [soldiers in a cult-run army](#).

As humans, we have an unwritten law: kids are off limits. Children are to be cherished and protected, no matter their race, background, or circumstances. And for those of us who are Christians, the command is even clearer:

"Defend the weak and the fatherless; uphold the cause of the poor and the oppressed." -Psalm 82:3

This is a war on the innocent. And if we won't fight for children, judgment will fall on the complicit.

HIDDEN IN PLAIN SIGHT

“Anti-Family” Court-Sponsored Child Trafficking. How looking out for the “Child’s Best Interest” has become a lucrative, for-profit business scheme to destroy families!

Most people believe human or child trafficking is limited to forced labor, sexual exploitation, or crimes taking place at borders or in hidden locations. Few consider that a widespread form of family separation occurs openly within family court systems, where decisions are made under the banner of the “child’s best interest.”

Family courts are intended to prioritize a child’s physical, emotional, and psychological well-being when determining custody, visitation, and support. In practice, however, many parents report that evidence, testimony, and documented concerns appear to carry little weight, while outcomes frequently result in prolonged separation, financial devastation, and emotional harm to children and parents alike.

For many families, family court proceedings have become transactional rather than protective. Parents describe repeated procedural irregularities, loss or omission of filed records, inconsistent rulings, and a lack of accountability. These experiences often leave families feeling powerless, financially exhausted, and emotionally broken, with long-term consequences for both parents and children.

Custody interference is a major contributor to these outcomes. In many cases, one parent withholds children from the other parent—sometimes across state lines—before initiating custody modifications. This tactic can create an imbalance, leaving the other parent unaware of their children’s whereabouts and struggling to respond within a complex legal system. By the time court proceedings begin, the separation has already occurred, and the status quo is often preserved.

I experienced this personally. Years after my divorce, my children were withheld from me without cause. Over time, all four of my children were separated from me through custody actions that ignored extensive evidence, witness testimony, and professional evaluations.

I was denied access to my children for extended periods, resulting in severe emotional distress for both myself and my children, including mental health crises. Despite documented concerns, custody was repeatedly granted in ways that prolonged harm rather than alleviated it.

Over the course of my cases, I encountered numerous judges and attorneys, yet none appeared focused on preserving the parent-child relationship or safeguarding children from further trauma. Law enforcement agencies routinely declined involvement, characterizing these matters as “civil issues.” Appeals to prosecutorial authorities rarely resulted in meaningful action, leaving families without recourse.

The financial toll is staggering. Innocent parents routinely lose tens or hundreds of thousands of dollars attempting to maintain contact with their children. Parents are often excluded from school records, conferences, and essential information, making it nearly impossible to demonstrate changed circumstances or advocate effectively for their children’s welfare.

These patterns raise serious concerns about systemic incentives that prioritize prolonged litigation over family preservation. When children become the center of prolonged disputes, the emotional and financial costs fall almost entirely on families—while no meaningful accountability exists for outcomes that cause lasting harm.

I share this not only as a mother, but as an advocate for parents whose families have been effectively erased by a system that operates in plain sight. Children deserve stability, protection, and meaningful relationships with safe, loving parents. Any system that consistently produces devastation rather than healing demands transparency, reform, and accountability.


THE ROAD TO FREEDOM
